The company or the institution (hereafter called “the company”) requesting the LuxTrust SSL/TSL certificates must always provide:

- The filled-in **order form**, dated and signed by one or more representative(s) of the company (according to the company’s legal statutes or governing rules).
- A **double-sided copy of the identity card(s)** of the person(s) having signed the order form. Those copies have to be **duly signed** by the respective owners.
- A recent copy of the company’s **statutes** or alternatively of an equivalent <sup>(1)\*</sup> document.
- A relevant **recent\*\* copy of the company’s national trade and company register’s entries** (not older than 6 months) or alternatively of an equivalent <sup>(2)\*</sup> document.
- **Proof of signature power :**
  - If the signatory/signatories of the company is/are mentioned in the entries of the trade and company register as mandated persons to engage the company and if the persons(‘) signature(s) is/are sufficient to engage the company according to the statutory signature rules, no other item is needed to proof the signature power.
  - In case the power of the company’s signatory/signatories is not described in the entries of the trade and company register files and/or in the provided statutes (or equivalent documents) an additional document has to be provided proving the signature power of the signatory/signatories. Those items have to allow the registration authority to create the link between the signatory/signatories and the people mentioned in the entries of the trade and company registry and/or the statutes as being entitled to engage the company in the context of the respective law for statutory signatures (for instance a mandate).\*
